1st Floor: Entry from driveway into a breakfast area with adjoining kitchen with walk-in pantry. From this area there are also stairs up to the second level, storage closets and laundry facilities. Additional exterior door off from the kitchen leads out to the large wraparound porch. Through the kitchen is the formal dining room with fireplace, panel details and stunning ocean views. The formal entry way is located on the front of the house facing the Sound, in between the dining room and living room. Straight stairs up from the foyer to the second floor. The large, bright living room features lots of windows, a fireplace and an additional sun room off the backside with exterior entry to the driveway. There is a powder room located at the end of the central hallway.

2nd Floor: Two bedrooms located at the front of the property with breathtaking views. Two additional bedrooms face the Lincoln Circle

side of the property. Two full bathrooms on this level each with a clawfoot tub.

3rd Floor: Large, open central room with exposed beams and natural wood. Four bedrooms on this level share a full bath with clawfoot

tub.
